## OFFICIAL RULES

CU Hawaii Federal Credit Union is the sponsor of the Drawings. The Credit Union's business address is: 476 Hinano Street, Hilo, Hawaii 96720.

Entry Period: April 01, 2025, at 12:00 AM HST to April 18, 2025, at 11:59 PM HST.

Eligibility: To qualify for the Drawings, all entrants must be at least 18 years of age and be a Member in good standing with the Credit Union. Credit Union employees and officials are not eligible to participate in the Drawings. Entrants accept and agree to be bound by these Official Rules and the decisions of the Credit Union.

How to Enter: Eligible entrants can enter the Giveaway by doing one or more of the following actions before the Entry period deadline; (1) Use your CU Hawaii Debit card for at least ten (10) purchases, (2) Use your CU Hawaii Credit card for at least ten (10) purchases, (3) Download our CUHI Cards App, available in the Google and Apple app stores, and sign up for transaction notifications/alerts. Users who complete these actions before the Entry Period begins will also earn an entry. (4) Have an open Rewards Savings account, also referred to as a "Kasasa Saver" account. Account holders who opened a Kasasa Saver account before the Entry Period beginning will also earn an entry.

Completion of one of the actions noted above prior to the end of the Entry Period will serve as your entry into the Giveaway. For each action noted above Entrant will receive one entry into each individual prize giveaway. As a participant, each entry must fully meet all Giveaway requirements, as specified in the Official Rules, in order to be eligible to win a prize.
